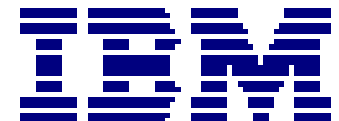
Roles

 - Test

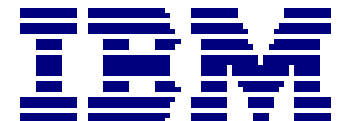
Small Business Roles as a part of the IBM Team

- Actively support IPT staffing requests to win competitively awarded positions



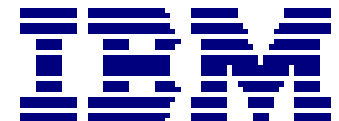
What IBM Looks for in Subcontractors

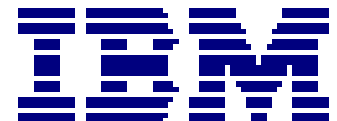
