B.2 General

The contractor shall provide, in accordance with issued task orders, all management, supervision, labor, facilities, and materials necessary to perform non-personal information processing support services on an indefinite delivery/indefinite quantity (IDIQ) basis. Individual task orders may be awarded as cost plus fixed fee (CPFF), firm, fixed price (FFP), labor hour, or time and materials (T&M). Task orders will be issued in accordance with the procedures set forth in sections H, I, and J.

B.3 Contract Minimums and Maximums

- a) Minimums -- Each Full and Open Competition contractor is guaranteed a total minimum of \$100,000. Each Partial Small Business Set-Aside Competition contractor is guaranteed a total minimum of \$50,000. The minimums are to be obligated during the base year and are inclusive of fee.
- b) Maximums – It is anticipated that 65% of the number of task orders issued under the TIPSS-3 Program will be awarded to Full and Open Competition contractors, and 35% of the number of task orders issued will be awarded to Partial Small Business Set-Aside Competition contractors.
- c) Tasking during the initial contract term and throughout the contract option periods will be accomplished through the issuance of task orders.

B.4 Payment of Fee (CPFF Only)

Subject to the withholding provisions of [Federal Acquisition Regulation \(FAR\) 52.216-7](#) "Allowable Cost and Payment" and [FAR 52.216-8](#) "Fixed Fee," (see section I.2) the contractor, at the time of reimbursement of allowable cost, will be entitled to payment of the fixed fee determined in each initial task order award. The same ratio of fee awarded in the initial contract award will be used in any task orders issued.
