Online tax assistance is available for people who speak other languages

If your native language is not English, the IRS website has tax information available for you in the following languages: Spanish, Chinese, Vietnamese, Korean and Russian.

Spanish

The [EITC Assistant](#) can help you find out if you're eligible for the Earned Income Tax Credit, a tax credit for certain people who work and have earned income under \$52,427. By answering questions and providing basic income information, you'll be able to:

- find out your filing status,
- determine if your child or children meet the tests for a qualifying child,
- find out if you're eligible for EITC, and
- estimate the amount of credit.

Many [forms](#) and [publications](#) are also available in Spanish.

Other Languages

The IRS also offers a variety of information and tools in Chinese, Korean, Vietnamese and Russian. For example, the [Taxpayer Bill of Rights](#) is available in six different languages: English, Spanish, Chinese, Korean, Russian and Vietnamese.

The Taxpayer Bill of Rights contains 10 key provisions that apply to all taxpayers:

1. The Right to Be Informed
2. The Right to Quality Service
3. The Right to Pay No More than the Correct Amount of Tax
4. The Right to Challenge the IRS's Position and Be Heard
5. The Right to Appeal an IRS Decision in an Independent Forum

6. The Right to Finality
7. The Right to Privacy
8. The Right to Confidentiality
9. The Right to Retain Representation
10. The Right to a Fair and Just Tax System

Accessible IRS Tax Products
