Updated versions will be posted as they become available. If any issues exist with any drop 1 schema or business rules, a known issues list will be made available on IRS.gov.

The 94x Drop 1 schemas & business rules have posted to IRS.gov. This update includes 2014 Filing Season changes for the 94x Modernized e-File (MeF) program. These schemas will not be implemented in the MeF ATS or Production environments. We are continuing to make updates to the schemas and rules for additional Filing Year 2014 changes. Subject: Modernized e-File (MeF) Registered User Portal Upgrade

IRS is in the process of completing a multi-year upgrade to the on-line portal infrastructure. The MeF application version and current supported schemas will not change as part of this migration. The first phase of the IRS portal upgrade was the transition to a new IRS.gov in August 2012. The second phase supports all registered user applications and is scheduled to be implemented over the Labor Day weekend of August 31 through September 2, 2013, with full operation on September 3, 2013. All software developers, transmitters, and states will need to make changes to transition from the RUP to the new Integrated Enterprise Portal (IEP).

Information Highlights:

- The MeF Production and ATS environments will be migrated to the new portal (IEP) and will be fully operational to all software developers, transmitters and states on Tuesday, September 3, 2013 at 12:00 p.m. ET. The MeF application version and current supported schemas will not change.
- The new portal (IEP) will require new public SSL certificates for establishing the SSL connection. Your software or browser configurations may be set up to automatically download these certificates when it connects to the new portal (IEP) the first time. Information on where you can manually download them is located in the *Portal Transition Guide* on the MeF User Guides & Publication page.
- A2A toolkit users (SDK and client application) are also impacted by these changes. Please read
 the Portal Transition Guide for more details.
- Testing in ATS through the new portal will be available on Monday, August 12, 2013 at 12:00 p.m. ET. The new "la.alt" URL listed in the *Portal Transition Guide* will be used for this purpose. The IRS encourages comprehensive and frequent testing through the new portal (IEP).
- Software developers, transmitters, and states that need to access the ATS environment through the current portal to pass ATS or retest their software can continue to use "la main." The "la main" URL will not be impacted prior to the September 3, 2013 full migration.

Timeline of Events:

- August 12th 12:00 p.m. ET Transmitters will be able to test reaching ATS through the new portal (IEP) using the new "la.alt" URL listed in the *Portal Transition Guide*. See the *Portal Transition Guide* for testing and how to get support during the migration.
- August 30th to September 2nd Labor Day Power Outage. ATS and Production environments of MeF will be unavailable. Additional information will be provided in an upcoming QuickAlert.
- September 3rd 12:00 p.m. ET MeF will be fully available to all users. All MeF traffic will go through the new portal (IEP). The Production and ATS URLs will not change.
- Software developers, transmitters, and states that need to access the ATS environment through the current portal to pass ATS or retest their software can continue to use "la main." The "la main" URL will not be impacted prior to the September 3rd, 2013 full migration.

Subject: Foreign Tax Credit Compliance Tips

The foreign tax credit laws are complex. Below are some quick summaries of the more complex areas of the law along with links to web pages on IRS.GOV with additional helpful resources.

Foreign Sourced Qualified Dividends and Gains

If a taxpayer receives foreign sourced qualified dividends and/or capital gains (including long-term capital gains, unrecaptured section 1250 gain, and/or section 1231 gains) that are taxed in the U.S. at a reduced tax rate, the taxpayer must adjust the foreign source income that is reported on Form 1116, line 1a. Otherwise, the allowable foreign tax credit may be significantly overstated which can trigger a substantial underpayment penalty.

Interest Expense

Interest expense must be apportioned between U.S. and foreign source income using an asset method. See Publication 514 for more information on the asset methods.

Other Compliance Issues

- Charitable contributions are not apportioned against foreign source income.
- The amount of foreign tax that qualifies is not necessarily the amount of tax withheld by the foreign country. If you are entitled to a reduced rate of foreign tax based on an income tax treaty between the U.S. and a foreign country, only that reduced tax qualifies for the credit.
- If a foreign tax redetermination occurs, a redetermination of your US tax liability is required in most situations. You must file a Form 1040X or Form 1120X. Failure to notify the IRS of a foreign tax redetermination can result in a failure to notify penalty.
