This is a reminder that if you own or operate a Website(s) that collects, transmits, stores or processes taxpayer information, IRS requires you to <u>register the URL(s)</u> on your e-file application. If you have not previously registered, select the URL collection link on the e-file application information page menu to register.

Online Providers must answer the self-certification questions annually beginning October 1 to ensure they comply with Publication 1345 IRS e-file security, privacy and business standards.

# QuickAlerts - November 7, 2014

Subject: Modernized eFile (MeF) Production and ATS Environment Change

The IRS will soon disable the Secure Socket Layer (SSL) version 3 protocol on the Application to Application (A2A) channel. This change will affect the "la.alt" URL that is currently being used to access the Assurance Testing System (ATS) environment and the "la main" URL that is used to access the Production environment.

Software developers and transmitters should ensure they are using Transport Layer Security (TLS) 1.0 or higher rather than SSLv3. SSLv3 will be disabled on November 14, 2014 for the "la.alt" URL that is currently being used to access the Assurance Testing System (ATS) environment. It is recommended that software developers test their software for the upcoming filing season in the ATS environment. The change has already been made to "la1.alt" and "la2.alt" URLs so developers can now test in the ATS environment for the upcoming release.

On December 29, 2014, SSLv3 will be disabled on "la main" URL that is used to access the Production environment. The change has already been made to "la1" and "la2" URLs so developers can now test in the Production environment.
