This information is extracted from the Individual Return Transaction File (IRTF) and the Business Return Transaction File (BRTF). The current year data and three prior years are maintained.
- (2) **Purpose:** This transmits revised IRM 2.3.63, IDRS Terminal Responses, Command Codes RPVUE, RPVCU and RPPRT.
- (3) **Audience:** LMSB, SBSE, TEGE, Return Preparer Office, and W&I.
- (4) **Policy Owner:** Kaschit Pandya, Acting Chief Information Officer
