Subject: Distribution of Modernized e-File (MeF) New Web Service Definition Language (WSDLs)

WSDLs for Tax Year 2014/Processing Year 2015 are now available. These WSDLs are scheduled to be installed in the MeF test environment (ATS) in November, 2014. These new WSDLs will also be required for MeF Production when it opens for Processing Year 2015.

As a reminder you should be using the "la.alt" (la.alt.www4) for ATS and "la main" URL (la.www4) for Production environments.

Subject: Verify your Electronic Filing Identification Number (EFIN) activity and other e-file application information

Check the EFIN status by logging into your e-file application through <u>e-services</u> to make sure the summary of the volume and activity of the returns e-filed in the last two years matches your records. Subject: Prior Year Return XML Standardization for Processing Year 2015

This Quick Alert is being sent to clarify information provided during today's Software Developer's Conference. During the conference it was shared that there will be XML standardization changes for prior year return Schemas, this information is correct. This will result in incrementing the package to a major version for each of the Parent Forms on the MeF platform. The following prior year Schema packages are the only ones effected and Diff files will be provided:

- efileAttachments.xsd
- efileMessageCommon.xsd
- efileMessageIFA.xsd

XML standardization will not impact the individual form level Schemas for the prior years.

These changes will not be in effect until November 2014 for ATS and January 2015 for production. The following forms will not have prior year Schemas:

- Form 56
- Form 9465
- Form 2350
- Form 4868

We will issue a Quick Alert when the Schemas are posted to IRS.gov. We will also be posting corresponding Business Rules for each package. There will be no change to the Business Rules.
