**IRM 3.12.154.7.12.3 - Field 01ARI - Updated Invalid Conditions and Correction Procedures for better flow of correction actions.**

(1) Field 01ARI is on page 1 of the Form 940 below the Type of Return check box.

**(2) Invalid Conditions:**

- a. The entry is other than "0, 1, 2, or 3".
- b. The tax period is before 202512.

**(3) Correction Procedures:**

(4) Compare the screen entry with the entry on the return and do the following:

- Blank or No Schedule R is attached, enter "0" in Field 01ARI.
- Section 3504 Agent is checked, enter "1" in Field 01ARI.
- Certified Professional Employer Organization (CEPO) is checked, enter "2" in Field 01ARI.
- Other Third Party is checked, enter "3" in Field 01ARI.

Multiple Boxes or No Box is Checked and Schedule R is attached,	Edit from the Check Box of the Schedule R.
Multiple Boxes or No Box is Checked and Schedule R is attached with Multiple or No Boxes Checked,	There is no indication Code and Edit initiated correspondence. Correspond for clarification
Any Box or Multiple Boxes are checked and Schedule R is NOT attached,	There is no indication Code and Edit initiated correspondence. Correspond for clarification

**IRM 3.12.154.7.3.2(1) - Updated note in 3rd Then table to clarify instructions on sending 3875C letter when EIN field is blank. Feedback from Campus.**

(1) Check the field with the return and do the following:

If	Then
The EIN was transcribed incorrectly,	Enter the correct EIN.
The EIN was transcribed correctly,	Search for another valid EIN on the return or attachments and enter the correct number.
A correct number cannot be decided,	<p>a. Research using CC NAMEB, CC NAMEE, or CC INOLE for the correct number.</p> <ol style="list-style-type: none"> <li>1. If a valid EIN is found, enter the correct number.</li> <li>2. If EIN is changed from the one the taxpayer used, send Letter 3875C, <b>Missing or Incorrect EIN on Return - BMF/EPMF</b>, as a non-response letter to the address on the return. Continue processing the return.</li> </ol> <p><b>Exception:</b> Do not send Letter 3875C when:</p> <ul style="list-style-type: none"> <li>• Three or less digits of the EIN are transposed, different or missing, or</li> <li>• The EIN is consecutive numbers (e.g., 12-3456789) or repeating numbers (e.g., 11-1111111), or</li> <li>• INOLEs shows the account was "merged to" or "merged from", or</li> <li>• The taxpayer uses their SSN in EIN format or fails to include their EIN and research shows there is a valid EIN for the taxpayer.</li> </ul>
More than one number is found or if unable to decide valid EIN,	Suspend with AC 320 for referral to Entity Control.
Entity assigns an EIN,	<p>a. Enter the EIN in Field 01 EIN.</p> <p>b. Enter the Entity Assigned Date in Field 01CRD if the date is after the return due date.</p>
