For example, in the 'CoveredIndividualGrp', choose either the 'CoveredIndividualAnnualInd' or the 'CoveredIndividualMonthlyIndGrp', but not both. If you choose both, the schema will reject.	If selecting a choice, choose just one of the two elements.
