

# MINUTES Internal Revenue Service Advisory Council Public Meeting

April 21, 2021, 3 p.m. ET

The meeting was opened by John Lipold, Designated Federal Officer, Branch Chief, Communications and Liaison, IRS Office of National Public Liaison, who provided housekeeping information regarding the call. Mr. Lipold welcomed the public to the Internal Revenue Service Advisory Council's ("IRSAC") public work session briefing. Mr. Lipold turned the meeting over to Ben Deneka, Chairman, IRSAC.

Mr. Deneka outlined the agenda for the meeting, described the history and purpose of IRSAC, and introduced IRSAC's leadership team. He noted that the committee is structured to include five subgroups: Large Business and International ("LB&I"), Small Business and Self-Employed ("SB/SE"), Tax Exempt and Government Entities ("TE/GE"), Wage and Investment ("W&I"), and Information Reporting. Mr. Deneka noted that IRSAC will hold additional public work session briefings this year and that IRSAC's annual public meeting will be held on November 17, 2021.
