- For general lien information, type “**lien**” and select the “**Understanding a Federal Tax Lien**” page ([www.irs.gov/Businesses/ Small-Businesses-&Self-Employed/Understanding-a-Federal-Tax-Lien](https://www.irs.gov/Businesses/Small-Businesses-&Self-Employed/Understanding-a-Federal-Tax-Lien)).
- To get the total amount of your tax debt, type “**account**” and select the “**Your Online Account**” page ([www.irs.gov/ payments/your-online-account](https://www.irs.gov/payments/your-online-account)). Select “Sign in to your Online Account” to create or access your account.
