Go to [www.irs.gov](http://www.irs.gov), select “Forms and Publications>>” to:

### ■ View, Download, and Print Tax Products

- For forms and instructions, select “Form and Instruction number (PDF)”
- For publications, select “Publication number (PDF)”
- For a subject index to forms, instructions, and publications, select “Topical index”
- For prior year forms, instructions, and publications, select “Previous years”

### ■ Order Tax Products Online

- For Tax Products, select “Forms and publications by U.S. mail”
- For Employer Products (e.g. W-4, Pub 15) and Information Returns (e.g. W-2, W-3, 1099 series), select “Employer forms and instructions”
