The Gig Economy (also called the Shared/Sharing Economy) is an emerging issue with exponential and continued growth projected for the future. Workers currently have a decentralized communication network and the team would like to identify how these workers find tax information, as well as what the Internal Revenue Service (IRS) can do to assist them with finding information to meet their tax obligations. Small Business / Self Employed Research (SBR) will assist the team by organizing and coordinating focus group sessions with workers who will be identified and invited by the Fors Marsh Group (FMG), a market research firm/company. FMG will also secure virtual space/facilities for the focus group sessions, moderate the sessions, provide transcripts/notes from the sessions, and provide SBR with aggregated responses in a report. Focus group participants will be screened and selected from the contracted market research firm (FMG), who will recruit voluntarily participants from their database and use current solicitation methods. Study Population = Gig Economy Workers. Study Sample = Gig

Economy Workers who are in the contractor's database or respond to solicitation methods and voluntarily agree to participate in the focus groups when solicited. The Contractor shall recruit for 8 to 12 participants for each focus group, with a minimum of 6 participants per session (6 focus group sessions lasting one-hour each) - with the objective to retain 8 - 10 participants per session (48 - 60 total).

All records for the survey will be deleted or destroyed in accordance with approved retention periods.
