Instructions

Issuers of Individual Retirement Arrangement Statements should send Copy A of Form 5498 to the Internal Revenue Service using this Form 5499 as a transmittal document.

Copy A of Form 5498 should be filed annually for every statement issued whether or not a distribution has been made during the year.

If you are sending many forms, you may send them in conveniently-sized packages. On each package write your name and identifying number, number the packages consecutively, and place Form 5499 in package number one. At the top of Form 5499 show the number of packages. Postal regulations require forms and packages to be sent by first class mail.

Copies B and C of Form 5498 should be given to the participant between December 31, 1976 and January 31, 1977.

Calendar Year Basis.—File all Forms 5498 on the basis of the calendar year.

When to File.—Form 5499 must be used to summarize and transmit Forms 5498 on or before February 28, 1977.
