Each choice within the 1095BUpstreamDetail and 1095CUpstreamDetail are between two elements. Both elements are maxOccurs=1. Only one of the two choice elements should be included. For example, in the 'CoveredIndividualGrp', choose either the 'CoveredIndividualAnnualInd' or the 'CoveredIndividualMonthlyIndGrp', but not both. If you choose both, the schema will reject.	Choose just one element within the choices.
