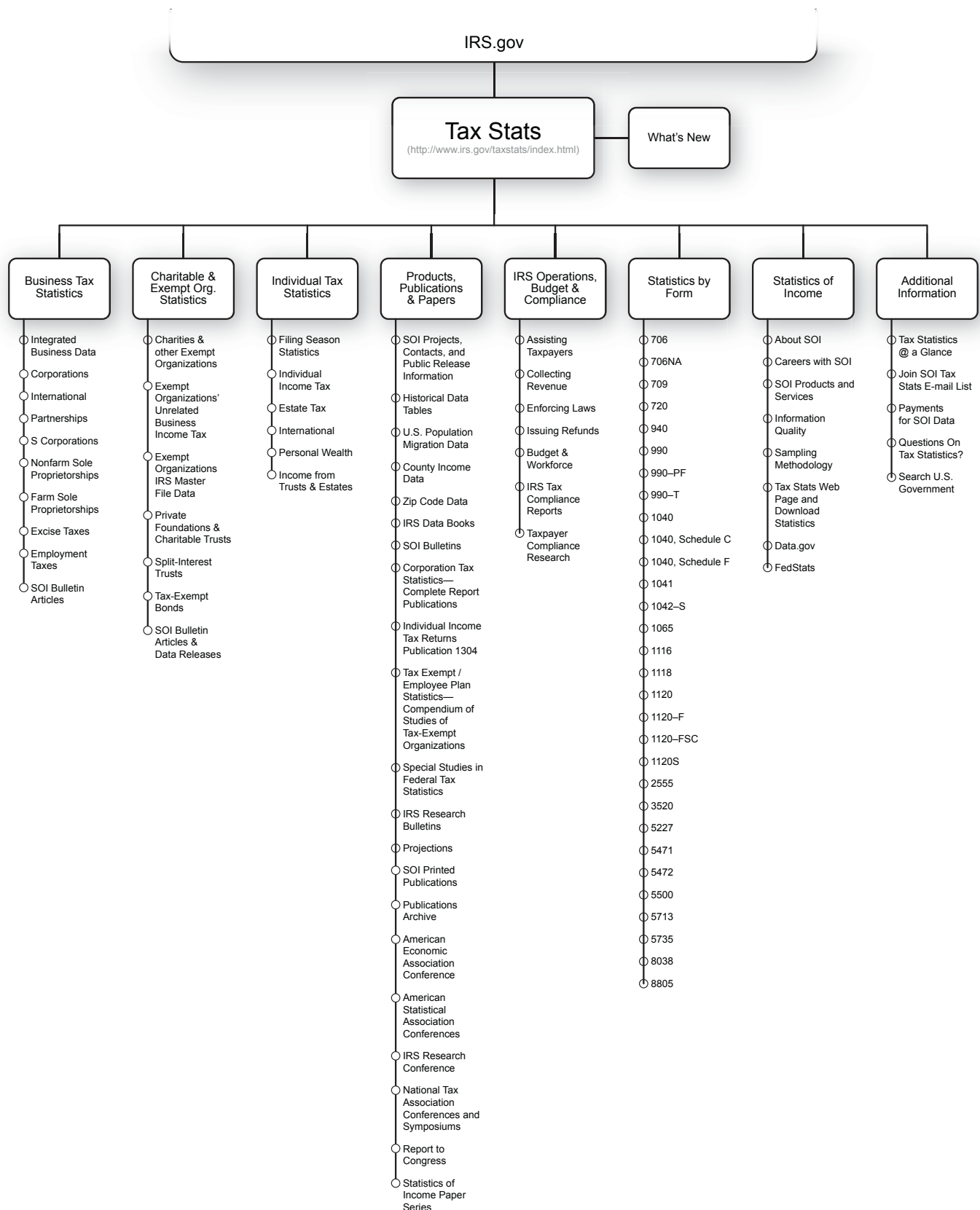

Summary

This document presents Calendar Year 2010 statistics on file downloads from SOI's Tax Stats Web pages. These statistics include the top ten downloaded files for the year, total downloads for all Tax Stats topics and descriptions of the related files. Also presented are email list subscription statistics and statistics on monthly downloads and web page views.

The total number of downloads from Tax Stats for 2010 was 7,780,194, an increase of 9 percent over the previous year's 7,117,281, marking 2010 as the year with the highest number of downloads since Tax Stats was launched in 1996. This continued an increasing trend in the number of yearly downloads; the yearly total has risen every year except 2003 and 2007. The average number of monthly downloads for 2010 was 648,350. July proved to be the most active month in terms of files downloaded, with 1,311,261. There were also 23,762 new subscriptions to the GovDelivery e-mail alert system in 2010, bringing the total subscriptions to 88,602.

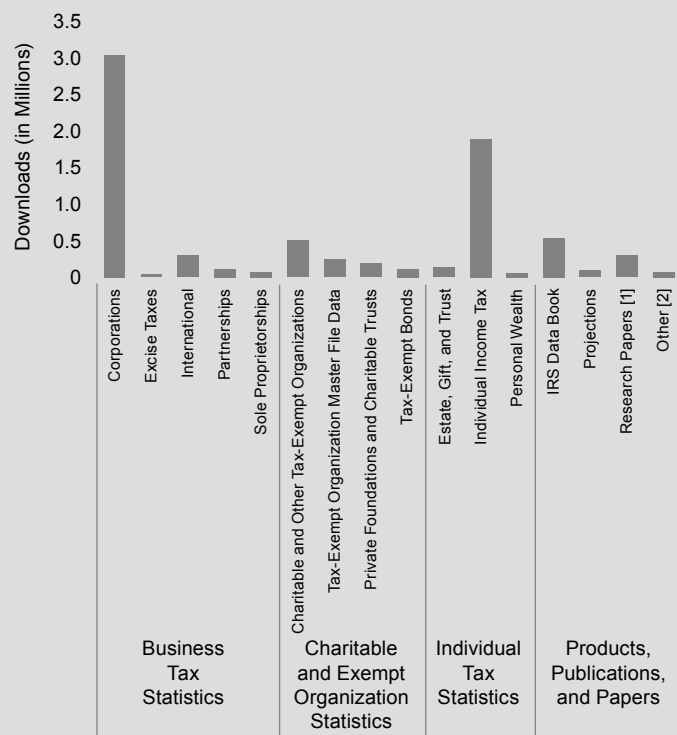
Business Tax statistics files accounted for the largest number of downloads by subject, with 3,591,636 files, or 46 percent of all downloads in 2010, 3,042,331 of which involved Corporation statistics files. Individual Tax statistics files accounted for next largest percentage of the total, which at 2,086,741 downloads constitute 27 percent of the total for the year. Files related to Charitable and Tax-Exempt Organizations statistics had 1,074,898 downloads in 2010. At 14,216 downloads, the single most sought after Tax Stats file for the year was, "The 400 Individual Income Tax Returns Reporting the Highest Adjusted Gross Income Each Year, 1992–2007."

Although files dealing with Business Tax statistics were, in total, the most downloaded during the year, downloads per file provide a different perspective. There were 158 Tax-Exempt Organization Master File Data files available for download in 2010, with a total of 254,781 downloads during the year. This is an average of more than 1,600 downloads per file, the highest average for 2010. Personal Wealth files and Tax-Exempt Bond files both averaged more than 1,200 downloads per file. By contrast, Corporation files, which had the highest number of downloads overall for the year, averaged 482 downloads per file. See Figure A and Figure B.

IRS Data Book files had 543,099 downloads, representing 7 percent of the total number of Tax Stats downloads for 2010. This was a slight decrease from the 563,786 downloads in 2009. Table 1, “Internal Revenue Collections and Refunds, by Type of Tax, Fiscal Years 2008 and 2009,” was the top downloaded *Data Book* table. The total number of downloads of the complete 2009 *Data Book* itself was 5,553. In addition, users downloaded the complete 2008 *Data Book* 2,703 times during the year.

In October 2010, SOI made almost 500 PDF documents available in the Archive section of Tax Stats. From October through December, the total number of downloads from the Archive was 22,504 files. In addition, during the last three months of the year SOI posted six “Tax Snapshots” on Tax Stats. These “Snapshots” provide a brief summary of and data highlights for several SOI studies, including Corporations, Partnerships, Charities, Private Foundations, Estates and Tax-Exempt Organization Unrelated Business Income. Users downloaded the “Snapshots” 3,864 times from October through December.

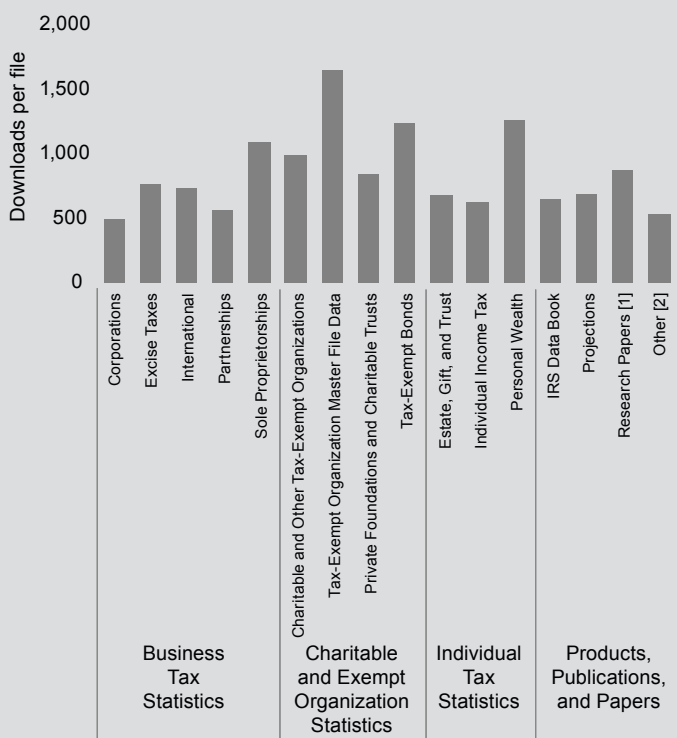
Figure A. Total Downloads from Tax Stats, by Topic, 2010

[1] Page-view rank is based on single access page visits. A single access page visit is a Web page on IRS.gov that visitors open, then exit, without viewing any other page. For example, a user may have a single IRS.gov Web page, such as the Individual Tax Statistics landing page, bookmarked in his or her browser. If the user accesses the page via a bookmark, then closes the browser (or navigates directly to a non-IRS.gov Web page), this would result in a single-access page visit in the usage analysis. Single-access page visits and page view ranks should not be confused with total Web page visits within the IRS.gov domain, which cannot be analyzed using the current Content Management Application.
