Subject: IRS modifies maintenance schedule; Modernized e-File open over Columbus Day weekend All times shown in this communication are in Eastern Standard Time.

Following concerns from the tax professional community, the IRS has modified its Columbus Day power outage to minimize the impact of this critical maintenance period as much as possible. This year, the Columbus Day weekend maintenance period will not affect the Modernized e-File operation, a change from previous years. The maintenance requirements, however, will affect the e-services secure mailbox operations between Sunday, Oct. 11 from around 3:00 a.m. Eastern Time until Monday, Oct. 12 at approximately 4:00 p.m. Eastern Time. Please note those times could vary, depending on normal maintenance issues.

During this period, the Transcript Delivery System, TIN Matching and e-File application will be available and you can use the online method to print and view your documents. However, if you choose to use the secure mailbox, you will not be able to retrieve your documents until after the maintenance period ends. Bulk TIN Matching and Transcript Delivery requests should be submitted by 2:00 a.m. Oct. 11, to ensure delivery to the secure mailbox prior to the start of the maintenance period. The IRS appreciates the feedback it has received regarding the Columbus Day period, and it has tried to reduce the impact of this outage as much as possible while balancing the need for timely system updates during a critical period. Subject: New IP PIN Business Rules

There are new MeF 1040 business rules related to the Identity Protection PIN. These business rules do not expand the IP PIN issuance process to include children but instead assist with return data integrity.

Starting January 1, 2016, the IRS will require the use of Identity Protection PINs for all SSNs with an IP PIN requirement, regardless of whether the SSN is entered for a primary, spouse, or dependent/qualifying individual. Entry of an IP PIN will be required for any SSN with an IP PIN requirement on the following Forms/Schedules:

- Form 1040, Individual Income Tax Return, series
- Form 2441, Child and Dependent Care Expenses

Schedule Earned Income Credit.

Subject: EITC Educational Compliance Letters

The IRS recently sent Earned Income Tax Credit Due Diligence letters to tax preparers who submitted incorrect or highly questionable EITC tax returns this past year.

The letters are for information purposes only. However, IRS will continue to monitor the EITC returns prepared in the upcoming filing season to see if the quality of the preparers' returns improves. Return Preparers who completed highly questionable EITC claims may receive one or more of the following letters:

- <u>Letter 5025</u>, You May Have Prepared Inaccurate EITC Returns with Questionable Qualifying Children and Self-Employment Income
- <u>Letter 5025C</u>, You May Have Prepared Inaccurate EITC Returns with Self-Employment Income
- <u>Letter 5025Q</u>, You May Have Prepared Inaccurate EITC Returns Based on Questionable Qualifying Children
- Letter 5138, Return Preparer EITC Client Audit Notification
