You are required to complete the MeF ATS Questionnaire for <u>each software package</u> that you are going to test.

You must be an authorized user listed on the IRS e-File application and have one of the following roles to submit questionnaires:

- Principal or user granted Principal Consent authority or
- Responsible Official **or** Delegate Users with Add & Change Software Package Information authority granted.

To complete the questionnaire and receive a Software Identification number for each product you plan to test, complete the steps below:

- Sign into your IRS e-file Application. Your application must be in completed status.
- Select **Organizational Role** from the Select Your Organization page.
- From the External Service Authorization Management landing page, select the **View/Edit** icon to access your completed application.
- Once in the application, select the **Software Packages** tab.
- Select **Add Software Package** toward the bottom of screen.
- Complete the Add Software Package Information pop-up.
- Once you have completed the required fields, select **Save**.

Note: If you have multiple packages, you will need to complete the pop-up multiple times.
