We are responding to correspondence, submitted on your behalf by [REDACTED] [REDACTED] [REDACTED] requesting relief in order to establish January 1, 1998, as the effective date for your S corporation election. The information submitted explains that an original election was mailed timely but not received by the Internal Revenue Service.

In Revenue Procedure 97-48 (copy attached) the Internal Revenue Service provides special procedures that permit taxpayers in certain situations to obtain automatic late S corporation relief instead of applying for a private letter ruling. The facts presented in your situation are covered by this revenue procedure and you have been granted relief. You should have recently received a letter confirming this fact.
