We are responding to correspondence requesting relief in order to establish 1998 as the effective taxable year for your S corporation status. The information submitted explains that you believed the Internal Revenue Service had received your election. However, according to Internal Revenue Service records, no such election has ever been received. The IRS records also reflect the only corporate return received for your company was for the 2000 taxable year. Although we are unable to respond to your request as submitted, this letter provides useful information about correcting your situation.

Announcement 97-4 (copy enclosed) provides guidance on seeking relief for late S corporation elections. Generally, to request relief for a late or invalid S corporation election you must request a private letter ruling from the National Office. The procedures for requesting a ruling are set out in Revenue Procedure 2002-1 (copy enclosed). In addition, a proper user fee must be submitted along with your request. The fee for a ruling is \$6,000; however, taxpayers with gross income of less than \$1 million for the last 12-month taxable period qualify for a **reduced user fee** in the amount of **\$500**. If your business qualifies for the reduced fee, your request must include a statement certifying gross income; otherwise, you will be billed the higher fee. Please format your ruling request as shown in Appendix B of Rev. Proc. 2002-1.

If you decide to submit a ruling request, please provide documents supporting your intention to be an S corporation from inception, and include the proper user fee. Please refer your package to our office by adding the following to the address:
