After review of the application you submitted on behalf of the _____ project, as amended by correspondence received by the Internal Revenue Service on February 9, 2006, and February 27, 2006, and after consultation with the Environmental Protection Agency, we are designating the _____ project as a qualified green building and sustainable design project under §§ 142(a)(14) and 142(l)(7) of the Internal Revenue Code (the "Code"). Further, pursuant to § 142(l)(7), we allocate authority to issue qualified green building and sustainable design project bonds for the project in an aggregate face amount not to exceed _____

Please note that in order for bonds to be qualified green building and sustainable design project bonds, the issuer must meet the applicable requirements of the Code, including without limitation § 142(l), and Notice 2005-48, 2005-27 I.R.B. 9, including without limitation, the requirements described in the following paragraphs of Notice 2005-48:

- CERTIFICATION OF USE OF TAX BENEFIT;
- REPORT OF COMPLIANCE;
- ACCOUNTABILITY;
- INFORMATION REPORTING; and
- COORDINATION WITH OTHER RULES GOVERNING QUALIFIED PRIVATE ACTIVITY BONDS.

While this office has not verified any of the material submitted in support of the request for rulings, it is subject to verification on examination.
