I looked at the partnership rules--only the activity of a partnership--i.e., production activity--and assets of a partnership are attributed to a partner in determining the partner's distributive share of partnership income--so that would just be the cost plus % amount you mentioned....so partnership assets would not otherwise be attributed even if the taxpayer were to be considered to be a manufacturer under these new Sub F principles.
