This letter responds to a letter dated April 1, 2025, and subsequent correspondence, submitted on behalf of  $\underline{X}$  by its authorized representative, requesting a ruling under § 1362(f) of the Internal Revenue Code (Code).

#### **FACTS**

According to the information submitted, <u>Sub</u>, a <u>State 1</u> corporation, elected to be an S corporation effective <u>Date 1</u>. <u>X</u>, a <u>State 2</u> corporation, elected to be an S corporation effective <u>Date 2</u>. On <u>Date 3</u>, incident to what <u>X</u> represents was part of a reorganization under § 368(a)(1)(F), <u>Sub</u>'s sole shareholder, <u>A</u>, contributed all the stock in <u>Sub</u> to <u>X</u> so that <u>Sub</u> became a wholly owned subsidiary of <u>X</u>. On <u>Date 4</u>, <u>Sub</u> converted to a <u>State 2</u> limited liability company and was treated as an entity disregarded as separate from its owner for federal tax purposes (disregarded entity). On <u>Date 5</u>, <u>X</u> made an election to treat <u>Sub</u> as a qualified subchapter S subsidiary (QSub) effective <u>Date 3</u>. Subsequently, <u>X</u> determined that the election to treat <u>Sub</u> as a QSub was ineffective because <u>Sub</u> did not meet the requirements of § 1361(b)(3)(B) at the time the election was made. Specifically, <u>Sub</u> was a disregarded entity and not a corporation as required under § 1361(b)(3)(B) and § 1.1361-3(a)(1) on <u>Date 5</u>.

 $\underline{X}$  represents that the ineffective QSub election for  $\underline{Sub}$  was inadvertent and was not the result of tax avoidance or retroactive tax planning.  $\underline{X}$  further represents that no person has filed a federal tax return inconsistently with a valid QSub election for  $\underline{Sub}$  effective  $\underline{Date\ 3}$ .  $\underline{X}$  and  $\underline{Sub}$  have agreed to make any adjustments required by the Service consistent with the treatment of Sub as a QSub effective Date 3.

#### LAW AND ANALYSIS

Section 1361(b)(3)(A) provides that, except as provided in regulations prescribed by the Secretary, for purposes of the Code- (i) a corporation which is a QSub shall not be treated as a separate corporation, and (ii) all assets, liabilities, and items of income, deduction, and credit of a QSub shall be treated as assets, liabilities, and such items (as the case may be) of the S corporation.

Section 1361(b)(3)(B) provides that the term "QSub" means any domestic corporation which is not an ineligible corporation (as defined in § 1362(b)(2)), if (i) 100 percent of the stock of such corporation is held by the S corporation, and (ii) the S corporation elects to treat such corporation as a QSub.

Section 1.1361-3(a)(1) of the Income Tax Regulations provides that the corporation for which a QSub election is made must meet all the requirements of § 1361(b)(3)(B) at the time the election is made and for all periods for which the election is to be effective.

Section 1362(f) provides, in part, that if (1) an election under § 1361(b)(3)(B)(ii) by any corporation was not effective for the taxable year for which made (determined without regard to § 1362(b)(2)) by reason of a failure to meet the requirements of § 1361(b), (2) the Secretary determines that the circumstances resulting in the ineffectiveness were inadvertent, (3) no later than a reasonable period of time after discovery of the circumstances resulting in the ineffectiveness, steps were taken so that the corporation for which the election was made is a QSub, and (4) the corporation for which the election was made, and each person who was a shareholder of the corporation at any time during the period specified pursuant to § 1362(f), agrees to make such adjustments (consistent with the treatment of the corporation as a QSub) as may be required by the Secretary with respect to such period, then, notwithstanding the circumstances resulting in the ineffectiveness, the corporation will be treated as a QSub during the period specified by the Secretary.

### **CONCLUSION**

Based solely on the facts submitted and representations made, we conclude that X's election to treat <u>Sub</u> as a QSub effective <u>Date 3</u> was ineffective. We further conclude that the circumstances resulting in the ineffectiveness of the QSub election were inadvertent within the meaning of § 1362(f). Therefore, <u>Sub</u> will be treated as a QSub effective <u>Date 3</u> through <u>Date 4</u> under § 1362(f), provided that the QSub election was otherwise valid and not otherwise terminated under § 1361(b)(3)(C).

Except as expressly provided herein, we express or imply no opinion concerning the federal tax consequences of any aspect of any transaction or item discussed or referenced in this letter. Specifically, we express or imply no opinion regarding whether <u>Sub</u> was otherwise eligible to be treated as a QSub or the validity of the reorganization under § 368(a)(1)(F) or its federal tax consequences.

The ruling contained in this letter is based upon information and representations submitted by the taxpayer and accompanied by a penalty of perjury statement executed by an appropriate party. While this office has not verified any of the material submitted in support of the requested ruling, it is subject to verification on examination.

This ruling is directed only to the taxpayer requesting it. Section 6110(k)(3) of the Code provides that it may not be used or cited as precedent.
