QuickAlerts – June 1, 2017

Subject: UPDATE for Scheduled Maintenance for the ACA Information Return (AIR) System

The AIR System will be offline for scheduled maintenance during the following time period:

June 8, 2017, starting at 11:59 p.m. Eastern through 7:59 a.m. Eastern on June 11, 2017.

Critical system updates will be deployed during this time period to both the AATS and Production environments. Please refrain from accessing the AIR System for both the A2A and UI Channels during this time period.

Subject: Assurance Testing System for Form 8975 and Form 8975 Schedule A for Tax Year 2016 opens June 18, 2017.

Four new Assurance Testing System (ATS) scenarios which include Form 8975 and Form 8975 Schedule A will be available on IRS.gov starting June 5, 2017. The scenarios are for Forms 1041, 1065, 1120 and F1120S.

Software developers are strongly encouraged to participate in the voluntary ATS testing for TY2016 beginning on June 18, 2017. Testing for those using this new form will be mandatory for TY2017.

Tax Year 2016 Schemas and Business Rules updates were available through e-Services accounts on May 19, 2017. These updates included the Form 8975 and Form 8975 Schedule A for the following forms:

Subject: Update on e-Services availability

The planned move of IRS e-Services to a different platform has been pushed to later this summer. This delay changes previous announcements to e-Services users.

1. The planned e-Services outage for June 15-19 has been cancelled.
2. State users will be able to submit new or update existing state e-file coordinator applications and TDS applications until the upgrade begins later this summer.

IRS will communicate the schedule for the e-Services platform upgrade and provide updates on user impact well in advance of any changes.

QuickAlerts – June 22, 2017

Subject: Important Update for AIR Users

The IRS currently is in the process of making a series of changes to the e-Services platform that will have a temporary impact on the ACA application process for a Transmitter Control Code (TCC.)

There will be no impact to users who electronically file through the Affordable Care Act Information Returns (AIR) program and who have Transmitter Control Code.

However, starting July 10, users will be unable to submit new ACA applications for TCC or make any changes to existing ACA applications for TCC. Because of the steps required in the ACA application review process, which includes some manual steps, the IRS asks that users submit **by July 2** any new ACA applications for TCC or any changes to ACA application needed to complete the Tax Year 2016 filing. The ACA application for TCC process will be unavailable for three to five weeks. We regret the inconvenience.
