This bundle provides information for taxpayers and partners about the free, easy, safe and secure IRS Direct File pilot. IRS Direct File allows taxpayers the option to electronically file a 2023 federal tax return directly with the IRS for the first time — for free.

Eligible taxpayers from 12 pilot states can file their tax returns 24 hours a day, every day in both English and Spanish.

Direct File accepts certain types of income, deductions and credits. Use the [eligibility checker](#) to learn if it supports your tax needs.

WASHINGTON – File your 2023 federal taxes online, for free, directly with the IRS for the first time.

With Direct File, you can:

- Add your tax information with step-by-step guidance
- Get live online support from IRS staff
- Use your smartphone, laptop, tablet or desktop computer
- Direct deposit your refund or make a tax payment online

Direct File is available for eligible taxpayers in 12 states: Arizona, California, Florida, Massachusetts, Nevada, New Hampshire, New York, South Dakota, Tennessee, Texas, Washington and Wyoming.

If you live in one of the 12 pilot states, visit directfile.irs.gov to see if you're eligible to join.
