Important information about the Additional Child Tax Credit

You may qualify for a refund

Your 2018 Form 1040 shows you have one or more dependents and may qualify for the Additional Child Tax Credit.

Do not discard this notice because you may be entitled to additional money.

Summary

The "Additional Child Tax Credit" is for certain taxpayers who get less than the full amount of the "Child Tax Credit."

- You may receive this credit even if you didn't owe any tax.
- You may be eligible even if you didn't qualify for the full amount of the Child Tax Credit.

What you need to do

Complete the Additional Child Tax Credit Worksheet on page 3.

If the worksheet confirms that you have at least one qualifying child

- Sign and date the attached Additional Child Tax Credit Worksheet.
- Complete the enclosed Schedule 8812.
- Mail the Worksheet and Schedule 8812 to us in the enclosed envelope.

Next steps

We'll verify your worksheet and schedule and determine if you qualify.

If you qualify

- We'll send you a refund check in 6-8 weeks if you don't owe other tax or debts we're required to collect.

If you don't qualify

- We'll send you a letter explaining why.

When you file your Form 1040 next year

Remember, to claim the Additional Child Tax Credit, complete and attach Schedule 8812 to your 1040 tax return.
