What you need to do

If you aren't required to file Form 8871

Complete, sign and date the Response form, and mail it to us using the enclosed envelope, along with any supporting documents so we receive it by March 4, 2016.

If you are required to file Form 8871

- File your Form 8871 at www.irs.gov/polorgs immediately.
- Complete, sign and date the Response form, and mail it to us using the enclosed envelope, along with any supporting documents so we receive it by March 4, 2016.

If you've filed Form 8871 previously, use your assigned username and password. If you're filing for the first time, you can file Form 8871 without a username and password. When you're done filing, submit Form 8453-X, Political Organization Declaration for Electronic Filing of Notice 527 Status, to request your username and password for the future. You should receive them in the mail within six weeks.

Next steps

- Until your Form 8871 is filed, report all income and contributions as taxable income on Form 1120 POL, U.S. Income Tax Return for Certain Political Organizations.
- Keep your username and password after filing your Form 8871. You may need to file Form 8872, Political Organization Report of Contributions and Expenditures, or Form 990, Return of Organization Exempt from Income Tax.
- If we require payment or select your report for examination, we'll notify you separately.

If we don't hear from you

If we don't receive your Response form and/or Form 8871 by March 4, 2016, penalties may apply.
