What you need to do

If you aren't required to file Form 8872

- If you'd like to claim QSLPO status, file an amended Form 8871 electronically.

If you are required to file Form 8872

- Complete, sign and date the Response form, and mail it to us using the enclosed envelope, along with any supporting documents so we receive it by March 4, 2016.
- File Form 8872 immediately. If you expect contributions or expenditures over \$50,000 or less, you can file electronically at www.irs.gov/polorgs or mail your form to the address above.

Use the username and password we assigned you when you filed your initial Form 8871 and Form 8453-X, Political Organization Declaration for Electronic Filing of Notice 527 Status. If you've lost or forgotten your username or password, indicate this on the Response form.

Next steps

If we require payment or select your report for examination, we'll notify you separately.

If we don't hear from you

If we don't receive your Response form and/or Form 8871 by March 4, 2016, penalties may apply. We may charge up to 35% of the contributions and expenditures you made, related to your late Form 8872 filing.
