What You Need To Do Immediately

Gather this information

- Form numbers (1040, 1040A, or 1040EZ) for the outstanding tax years
- Your filing status for the outstanding tax years
- Address from the outstanding tax years
- Your bank routing number
- Your bank account number

1. Go to www.irs.gov/payments/direct-pay
2. Select "Make a Payment"
3. Follow the instructions to make your payment for each outstanding tax year

Consequences If You Do Not Pay Immediately

- We may **seize (levy) your property or your rights to property** if you fail to comply. Property includes wages and other income, bank accounts, business assets, personal assets (including your car and home), Social Security benefits, Alaska Permanent Fund dividends, or state tax refunds.
- We can **file a Notice of Federal Tax Lien**, notifying your creditor that we have a claim (lien) against all your property. This message may appear on your credit report and harm your credit rating.
- The U.S. Department of State may **revoke your passport or decline to issue or renew a passport** if you have seriously delinquent tax debt totaling more than \$52,000. For more information, visit www.irs.gov/passports.

You may request a Collection Due Process hearing. If you wish to appeal this proposed levy action, complete and mail Form 12153, Request for a Collection Due Process or Equivalent Hearing, by [due date] to [IRS return address]. Submission of a timely hearing request will generally prevent levy action. If you do not file Form 12153 by [due date], you will lose the ability to contest Appeals' decision in the U.S. Tax Court.
